

GRACE ENGLISH LUTHERAN CHURCH COUNCIL MEETING 7.8.24

Vice President Terry Wallace called the meeting to order.

Council members present; Terry Wallace, Sandy Peschke, Becky Olsen, Pastor Rebekah, Heidi Schramer, Jody Ziemann, Bob Prellwitz, Craig Chovanec, Anita Lind. Absent; Linda Reetz. Congregation member present; Jean Dretske, representing the Investment Committee.

Opening Devotion. Given by Terry Wallace.

Approval of the Agenda. Terry moved the items; Investment Policy Statement, Investment Committee Language, Investment Committee Update, and Renaming of the General Investment Fund to the Capitol Improvement Fund, these items will follow the audience remarks. Motion made by Craig to approve the agenda with the amendments, seconded by Bob, motion carried.

No audience remarks.

Investment Policy Statement, first reading. Copies of the newly created policy provided to members. Discussion held. Suggested changes will be made for presentation at the August council meeting.

Investment Committee Language. Discussion held. One amendment was made to the language. Motion made by Anita to approve the Investment Committee language for the Constitution with the one amendment, seconded by Sandy, motion carried. The Investment Committee will be identified in the Constitution as Continuing Resolution, C13.10.B24.

Renaming the General Investment Fund to the Capitol Improvement Fund. Discussion held. Terry provided this written statement: "after review of the General Fund investments, this fund was previously called the Capitol Improvement Fund and was established in 1998. To clarify the intended use of this fund we would rename this fund back to the Capital Improvement Fund. The purpose of the fund would be to pay for any capital improvements and not for general operating expenses". Motion made by Anita to rename the General Investment Fund to the Capitol Improvement Fund, seconded by Jody, motion carried.

Disbursements from the Capitol Improvement Fund. Discussion held. Motion made by Anita to stop disbursements from the Capitol Improvement Fund and to take \$3154.00 of disbursements/month from the Leonard Jones Fund, seconded by Bob, motion carried.

Investment Committee Update. Jean provided the monthly investment profiles. Discussion held. The investment profile balances will be included on the monthly financial balance sheet, located in the bulletins.

Secretary's Report. June meeting minutes were circulated via email, corrections made. Motion made by Sandy to accept report as written, seconded by Craig, motion carried.

Treasurer's Report. June financial reports, including check details, presented. Motion made by Bob to accept reports as written, motion carried.

President's Report. Presented by Terry.

Finance Webinar, "Funding Forward". Information shared about the webinar. Discussion held. Members of the finance, investment and council will be invited to attend. Motion made by Sandy to purchase the webinar, seconded by Craig, motion carried. Total cost for webinar and materials, \$250.00.

Shared Ministry Covenant. The Covenant has been approved by the councils of Grace and First Lutheran, with the cost split of the Covenant, 55% Grace and 45% First Lutheran. The Covenant was effective 7.1.24. Sandy will provide copies of the signed Covenant to members at the August meeting.

Conflict and Communication Workshops. Cathy Cowling will hold workshops on 7.16, 7.24, and 8.6, all starting at 6pm. You do not need to attend all workshops, signup is requested to ensure enough materials are available.

Ground Rules document. Copies available if needed, signed copies will be filed.

Pastor's Report. Pastor Rebekah presented her written report of accomplishments and activities, her priorities for the next period, her challenges/roadblocks, lessons learned and opportunities for improvements. Priorities for the next period include; continuing to work on Confirmation lessons, continue homebound visits and to finish the grant request for ELCA Disabilities Ministries. Challenges included; scheduling visits with homebound members while attending meetings and holding office hours at each church. Lessons Learned/Opportunity for Improvement included; a plan to focus the next bible study on Ephesians, aligning bible study with the lectionary readings and the sermon focus. Hopefully this will help streamline preparations for preaching and leading bible studies, as preparing for two separate bible studies is time consuming. Pastor will be on vacation 7.11-7.18.24.

Committee Reports.

Fellowship and Caring. No report. Plan to meet on Sunday 7.14.24, following service.

Buildings and Grounds. Bob reported maintenance of grounds continues, ash tree has been removed, and mower maintenance completed. An upcoming project includes the cleaning of oven grates. Next meeting is 8.12.24 at 6pm.

Christian Education. Anita reported that Sunday School will start on 9.8.24 and end on 5.11.25. The first day, 'Rally Day' will include a build your own donut or bagel bar and an interactive activity with kids and adults during fellowship time. Reported that the curriculum will continue to be 'Sermons for Kids' and Sunday School will meet three times a month. New this year, kids will be excused following the welcome to worship, this will allow more time to meet and music will be incorporated twice a month. She also provided an in-depth list of the year's events. The next meeting is 8.11.24, following service.

Pastor Quello established the Good Samaritan Fund, he recognized a need to help members of our church and community. We never know when emergent needs may arise from unexpected events, sickness, death, or other family hardships. The fund can be a godsend to people at a time of crisis. The Biblical Good Samaritan story gives us the road map to the way in which we should show compassion to others in the world. God has blessed us abundantly but we never know when hardships may arise. God expects us to step up and show compassion in times of need.

Good Samaritan Fund. Copies of the current Good Samaritan Assistance Guidelines provided. Following lengthy discussion, Anita made the motion, effective immediately Pastor Rebekah and office staff have discretion over the Good Samaritan Fund, they will be reimbursed for expenses, and this will replace the current Good Samaritan Assistance Guidelines, seconded by Craig, motion carried.

Polka and Pie. The Service will be held 8.25.24. Council members will provide pies.

Adjournment. Motion made by Jody to adjourn, seconded by Anita, motion carried.

Join Us for the Funding Forward Course!

Funding Forward provides the tools and insights to move beyond the constant worry about finances to listen to God's voice more clearly. We invite everyone to participate in this collaborative learning experience as we explore innovative solutions to creating financially sustainable ministry models. This course is designed with the understanding that each church's path to financial sustainability is as unique as its mission and community.

This is not just about financial management; it's a journey of faith, stewardship, and community building by discerning God's mission for our congregation, understanding how we can meet the tangible needs of our local community, and using underutilized congregational assets.

The learning modules will include topics like why tithes and offerings are no longer enough for most congregations; identifying our congregation's assets; discerning God's mission; aligning money and mission; reimagining our congregation's property; exploring social enterprises; shifting our congregation's staffing model finding funding; and shifting our congregation's financial model. Each session will include short videos, time in God's Word, conversation, brainstorming, and more.

We will hear some examples from other churches that are trying different ways of serving their community; using their resources; working with other ministry organizations and more. What might it look like to rent out some of our unused building space? How about allowing people to use our commercial kitchen? Let's explore this course together and see where God might lead us to discover new opportunities for church funding and deepen our connection with God and our community.

Thrivent Action Teams

Did you know that anyone who is a Thrivent client is eligible to lead a Thrivent Action Team? Clients with benefit membership are eligible to lead two Thrivent Action Teams per calendar year, and clients with associate membership are eligible to lead one per calendar year.

What is an Action Team?

It is a team of friends, family, neighbors, or church members that work together to put on a fundraiser, educational event, or service activity. Thrivent will provide up to \$250 in seed money for the project.

How does it work?

- 1. Any Thrivent member can apply to lead a project. You sign up on Thrivent.com. If you need assistance stop by the church office and Sandy will be glad to help you.
- 2. When you are approved, Thrivent sends you an action kit with resources to support your project. This includes a Community Impact Card with up to \$250 in seed money.
- 3. You and your team bring the project to life.
- 4. You report the completion of the project to Thrivent and share the story of your impact.

Here are some examples:

- An action team card purchased the food for the bingo event making it possible for all of the proceeds to go to the food pantry.
- Action team cards help with covering the cost of Soul Food meals.
- An Action Team card was used to purchase notebooks and other supplies for the Lutheran World Relief school
 kits
- An Action Team card was used for the Little Dresses for Africa Project purchasing elastic and underwear.
- An Action Team card purchased diapers for the Layettes for Lutheran World Relief.

Constitution Corner

Our church constitution provision C4.06 refers to three expressions of the church:

*C4.06. References herein to the nature of the relationship between the three expressions of this church—congregations, synods, and the churchwide organization—as being interdependent or as being in a partnership relationship describe the mutual responsibility of these expressions in God's mission and the fulfillment of the purposes of this church as described in this chapter, and do not imply or describe the creation of partnerships, coventures, agencies, or other legal relationships recognized in civil law.

As members of the Evangelical Lutheran Church in America (ELCA), it's essential to understand how our church is structured and how each level contributes to our shared mission. You may have heard the terms "congregations," "synods," and the "churchwide organization" and wondered about their roles and relationships. Let's dive into what these expressions are and how they work together to fulfill God's mission.

The Three Expressions of the ELCA

1. Congregations

Our local congregations are the heart of the ELCA. They are the places where worship, fellowship, and ministry happen on a daily basis. Here, we gather as a community to worship God, grow in faith, and serve our neighbors. Each congregation is a unique expression of our faith, addressing the needs of its local context while contributing to the broader mission of the ELCA.

2. Synods

Synods are regional bodies that support and connect congregations within a specific geographic area. They provide resources, training, and guidance to congregations, helping them to thrive and carry out their ministries effectively. Synods also act as a bridge between congregations and the churchwide organization, facilitating communication and collaboration.

3. Churchwide Organization

The ELCA Churchwide Organization is the national body that provides leadership and coordination for the entire church. It supports synods and congregations through various programs, resources, and initiatives. It also represents the ELCA in national and global contexts, working to advance our collective mission and witness.

Interdependence and Partnership

The relationship between congregations, synods, and the churchwide organization is described as interdependent and in partnership. This means that each expression of the church has its distinct role and responsibilities but works together in mutual support and collaboration. Here's what that means in practice:

- Mutual Responsibility: Each level of the ELCA has a role in advancing God's mission. Congregations engage directly with their communities, synods provide support and connection, and the churchwide organization offers leadership and resources. This mutual responsibility ensures that our efforts are coordinated and effective.
- **Shared Mission:** We are all working towards the same goals—spreading the Gospel, serving those in need, and growing in faith. By working together, we leverage our collective strengths and resources to make a greater impact.

Living Out Our Connection

Understanding our church's structure helps us appreciate the broader picture of how we contribute to and support each other. Whether through local outreach, synod events, or national initiatives, every action we take is part of a larger tapestry of faith and service.

What is the Capital Improvement Fund?

At the July council meeting, after extensive research, it was determined that the money in the General Investment Fund is money that was intended for capital improvements. The name changed when funds were transferred to different institutions a few years ago. For clarification of the purpose of the fund, this account will be renamed back to the original name of the Capital Improvement Fund.

Looking toward the future, our building and equipment are aging. The purpose of the Church Capital Improvement Fund is to ensure that the church has the necessary financial resources to maintain and enhance its physical assets without compromising its day-to-day operational budget. These funds are to be used for long-term projects such as significant equipment purchases, physical improvements, renovations, or repairs to its property and facilities. It is not intended for general maintenance or operations.

The fund is built up over time through giving designated on envelopes, special donations, memorials, fundraising campaigns, or allocations from the church's general budget.

Church Conflict Workshops Recap by Cathy Cowling, Consultant

This summer about twenty-five members participated in a series of three conflict skills workshops, facilitated by our consultant, Cathy Cowling. The purpose of the trainings was to give members the knowledge and skills necessary to manage conflicts within our congregation in a healthier manner and improve communication; they also helped lay the groundwork for work we will be doing this fall to address past hurts and ongoing differences.

In the first session, we explored some of our associations and assumptions about conflict, learned about dynamics of conflict and the difference between interests and positions, identified steps to move from conflict to reconciliation, and learned how to get out of triangles and encourage people who are in conflict with another person to speak directly with that person. The second session focused on skills for effective listening, especially the need to ask open-ended questions to better understand the perspective of others. In the final session, we learned a process to help people both speak for what they need and to help move a conflict from a fight to a dialogue, and then worked at crafting the ground rules we as a community of faith would like to live by the next time there is a conflict.'
